1 Students shall dress and groom in a clean, neat and modest manner to avoid distracting or interfering
 2 with the operation of the school. When a student is attired in such a manner as to cause or likely cause
 3 disruption or interference with the operation of the school, the principal shall take appropriate action.

4 The following **Standard Dress** is acceptable as school attire for regular school days:

6 **Wear:**

- 7 1. Shirts may contain appropriate graphics and
- 8 may be sleeveless (not skin tight/no cleavage)
- 9 2. Pants (jeans or uniform pants), skirts, shorts,
- 10 dress at modest length
- 11 3. Pants and skirts with drawstrings or belts
- 12 4. Pants or skirts with elastic waist and ankles
- 13 5. Tennis shoes, boots, sandals with strap around
- 14 the heel
- 15 6. Leggings/tights okay with shirt of modest length
- 16 covers front and back
- 17 7. Ear piercings

19 **Do Not Wear:**

- 20 1. Cut offs, frayed, mesh, or see-through shirts,
- 21 shirts showing midriff, cleavage or
- 22 undergarments
- 23 2. No pants/shorts worn below the waist, no skin
- 24 showing, no holes, rips, tears, frays
- 25 3. Hoods over the head
- 26 4. No pajama pants
- 27 5. Any clothing that promotes the use/consumption
- 28 of alcohol, tobacco, drugs, or has inappropriate
- 29 messages or sexual innuendoes
- 30 6. Sunglasses, except medically required
- 31 7. Hats, bandanas, head coverings inside school
- 32 buildings except where required by medical
- 33 conditions or religious customs
- 34 8. Heelys, flip flops, or house shoes

- 10 shorts, dress at modest length
- 11 3. Pants and skirts with drawstrings
- 12 4. Pants or skirts with elastic waist and ankles
- 13 5. Tennis shoes, boots, sandals with strap around the
- 14 heel
- 15 6. Leggings/tights okay with shirt (no cleavage)
- 16 modest length and covers front and back
- 17 7. Ears or piercings that are flush to the face

19 **Do Not Wear:**

- 20 1. Jerseys, cut offs, frayed, mesh, or see-through shirts
- 21 showing midriff, cleavage or undergarments. No
- 22 sleeveless shirts
- 23 2. No pants/shorts worn below the waist, no skin
- 24 showing, no holes, rips, tears, frays
- 25 3. Hoods over the head
- 26 4. No pajama pants
- 27 5. Any clothing that promotes the use/consumption
- 28 of alcohol, tobacco, drugs or has inappropriate
- 29 messages or sexual innuendoes
- 30 6. Sunglasses, except medically required
- 31 7. Hats, bandanas, head coverings inside school
- 32 buildings except where required by medical
- 33 conditions or religious customs
- 34 8. Heelys, flip flops or house shoes

1 The following **Unity Dress** is acceptable as school attire each Wednesday for Unity Day countywide. It can
2 also be worn any other day at parents' discretion or designated district events.

4 **Wear:**

- 5 1. District approved polo preferably with F5 logo/shield (Light Blue, Light Pink, Charcoal Gray, Royal Blue,
6 White).
- 7 2. District approved t-shirt with F5 logo/shield is acceptable to wear
- 8 3. Jeans/pants/skirts modest length
- 9 4. All pants worn at the waist
- 10 5. Tennis shoes with laces tied, boots, sandals with strap around the heel worn at all times

12 **Do Not Wear:**

- 13 6. Sweat/wind pants, hats, bandanas, head coverings inside school building except where required by
14 medical conditions or religious customs
- 15 7. No pants/shorts worn below the waist, no skin showing, no holes, rips, tears, fraye
- 16 8. Heelys, flip-flops or house shoes
